1.Name : (CACSA)

COASTAL AREA CHURCHES OF CHRIST & SOCIAL ACTION

3.MEMBERSHIP:

Any person who is aged about 18 years is eligible for membership the admission .Fee is Rs.10/- (Ten Rupees only) . If any member fails to pay the yearly I subscription in time, his membership ceased and the same will be cancelled automatically admission of a new member should be approved by the Management Body. *

4.GENERAL BODY:

The annual General Body meeting will be held in the month of March every year. This general body will elect the Executive Body for every five (5) Years. The duties of the General Body are to pass the Budget for the ensuing year, to approve the expenditure of the previous year, to appoint an Auditor, to chalk-out the programme for the development for.

5. EXECUTIVE BODY:-

In consists of 7 (seven) members i.e., (1) President (2) Vice President (3) Secretary (4)Treasurer and $\frac{1}{4}$ other members . The duties of the members will be finalized by the Executive Body and they will meet once in every month . The life of the Executive Body will be five (5) years. ✓

6. DUTIES OF THE EXECUTIVE BODY:-

1.PRESIDENT:-

He is the figure head of the CACSA society and shall preside both the meeting of General Body and executive Body . He has got power to utilize his casting vote .He shall have power to use the funds up to Rs.10,000/- (Rupees Ten Thousand only) for emergency purpose and should get the same ratification in the next ensuing General Body Meeting.

The president is held responsible for them , for the purpose of custody. He shall operate the bank account of the society will be operated by president, and Treasurer jointly. He shall have power to appoint good workers for the society and to maintain the administration of the society.

2.VICE – PRESIDENT:-

In the absence of the President, the duties of the president will be performed by Vice – President.

3.SECRETARY:

The secretary should call for the General Body. He has to record the minutes of the meetings. He is responsible for the Executive Administration of the Society.

4. TREASURER:-

He has to receive donations, subscriptions from president which were collected from the public and issue receipt for the said collections to the secretary. He will prepare and present all accounts to the auditor, General Body and to the executive Body. He will operate society Bank accounts jointly with the President.

5. MEMBERS:-

The members will help to the above for the Development of the CACSA .

6.QUORUM:-

The Quorum for the General Body as well as to the Executive Body is $\frac{1}{4}$ th of the Members.

7. FUNDS:-

The funds shall be collected by way of subscriptions , contributions and donations etc., the money should be spent for the achieving the objects of the CACSA society only. They should not be used for the personal needs of the individual.

8.AMENDMENTS:-

Amendments to the objects and Rules must be made in the General Body with $\frac{3}{4}$ th majority. Such amendments must be confirmed in the second special General Body meeting intended for the purpose only $\frac{3}{4}$ th members present and voting within one month from the first meeting.

9.LIQUIDATION:-

In case of the society has to be liquidated the properties of the CACSA society without liabilities should liquidated in favour of the CACSA society having the same aims and objects with the consent of the $\frac{3}{4}$ th members of general body.

10.FINANCIAL YEAR :-

Financial Year of the society shall be from 1st March to 31st of the next year.

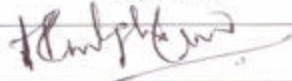
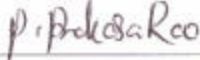
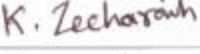
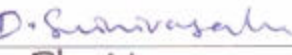
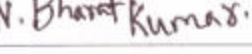
11.ELECTIONS:-

The annual meeting of the General Body shall be held in the month of March of every five years. The office bearers shall be elected at the time of collaboration of annual meetings.

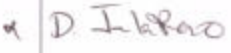
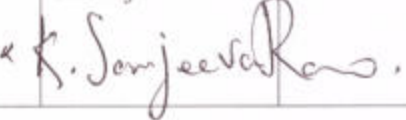
